

AGREEMENT

- I -

This Agreement is entered into by and between the United States Army Vietnam (USARV) and the Republic of Vietnam Armed Forces (RVNAF).

- II -

IT IS UNDERSTOOD THAT: The signatories to this Agreement have full authority to represent, negotiate, sign and obligate their respective principals with regard to the provisions of this Agreement.

- III -

IT IS UNDERSTOOD AND AGREED THAT: The purpose of this Agreement is to formalize the intent and understanding of the U. S. and RVNAF as specifically applicable to the physical and legal transfer of Camp Davies from USARV to the RVNAF.

- IV -

IT IS UNDERSTOOD THAT: Camp Davies consists of approximately 38 hectares of land in Gia Dinh Province near the city of Saigon, shown on the shaded map overlay (Sheet name: Saigon City Plan, map number II, Scale: 1, 10, 000) at Appendix I.

- V -

IT IS UNDERSTOOD THAT: The U. S. is not transferring all of Camp Davies to the RVNAF at this time. The U. S. will retain a portion of Camp Davies (shown on map at Appendix I) for an indefinite period. The portion being retained by the U. S. will be occupied by various US units and agencies, the size, nature and strength of which are not to be affected by anything within this agreement. The U. S. will have free and continuous access to this area from LTL 15 on Duong Kho.

- VI -

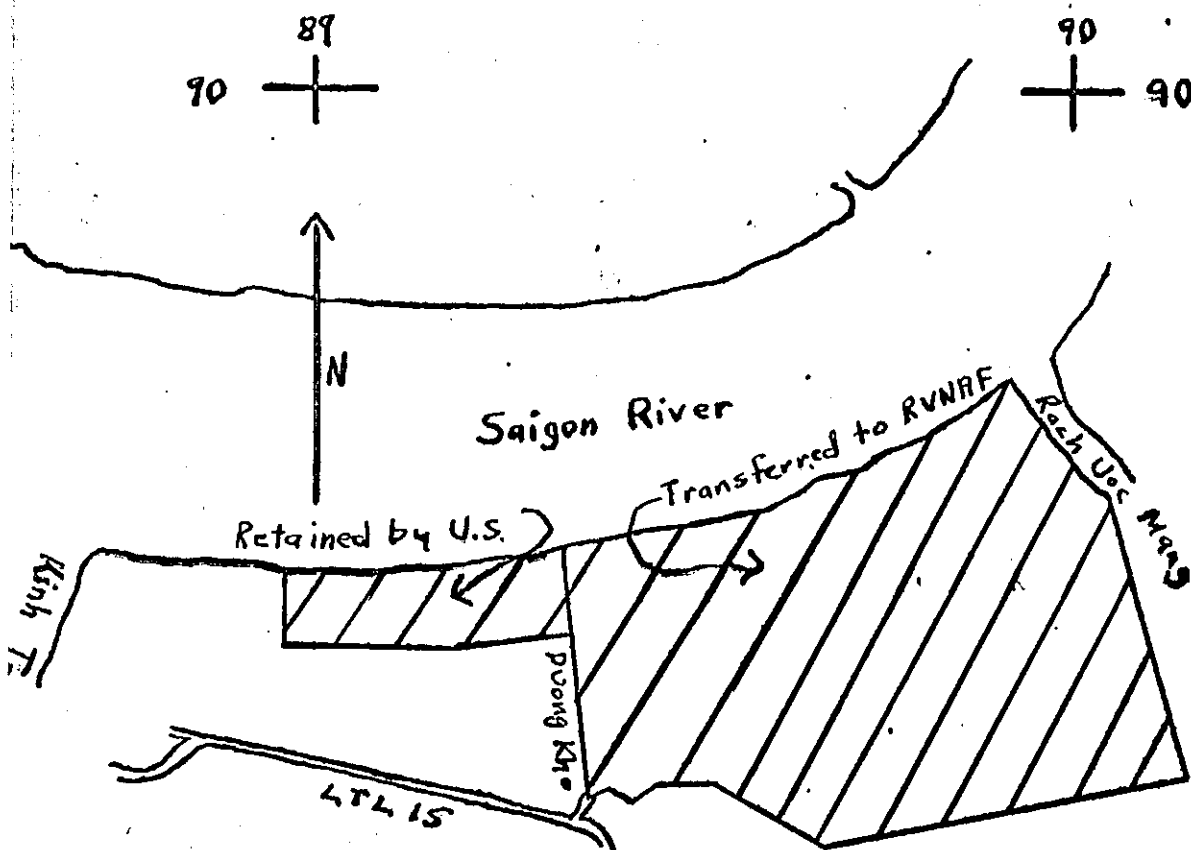
IT IS UNDERSTOOD THAT: The area to be transferred, as indicated on the map at Appendix I, is approximately 33.8 hectares and is defined as follows: with the boundary starting at grid coordinate XS 89378907 and proceeding generally East through coordinates XS 89398907, XS 89428907, XS 89458908, XS 89538908, and XS 89688900 to XS 90158910, then proceeding North to coordinate XS 90058947 on the Rach Uoc Mang (Saigon River tributary), then proceeding along the tributary to the Saigon River at coordinate XS 89918962, then proceeding along the Saigon River bank to coordinate XS 89338940, then along Duong Kho to the starting point at coordinate XS 89378907.

- VII -

IT IS UNDERSTOOD AND AGREED THAT: The above described portion of Camp Davies which is being turned over to the RVNAF is being turned over as an operational military facility for the sole use of the RVNAF, utilization of which will be determined by the Republic of Vietnam Joint General Staff.

- VIII -

IT IS UNDERSTOOD AND AGREED THAT: Except as noted in paragraph XVI below, equipment, materials and fixtures located at, on, in and around buildings and facilities, and grounds at the portion of Camp Davies which is being turned over to the RVNAF, as well as buildings, other structures and facilities located at and on the portion of Camp Davies which is being turned over to the RVNAF at the effective time of transfer are transferred to the RVNAF simultaneously with and as a part of the transfer of Camp Davies.
