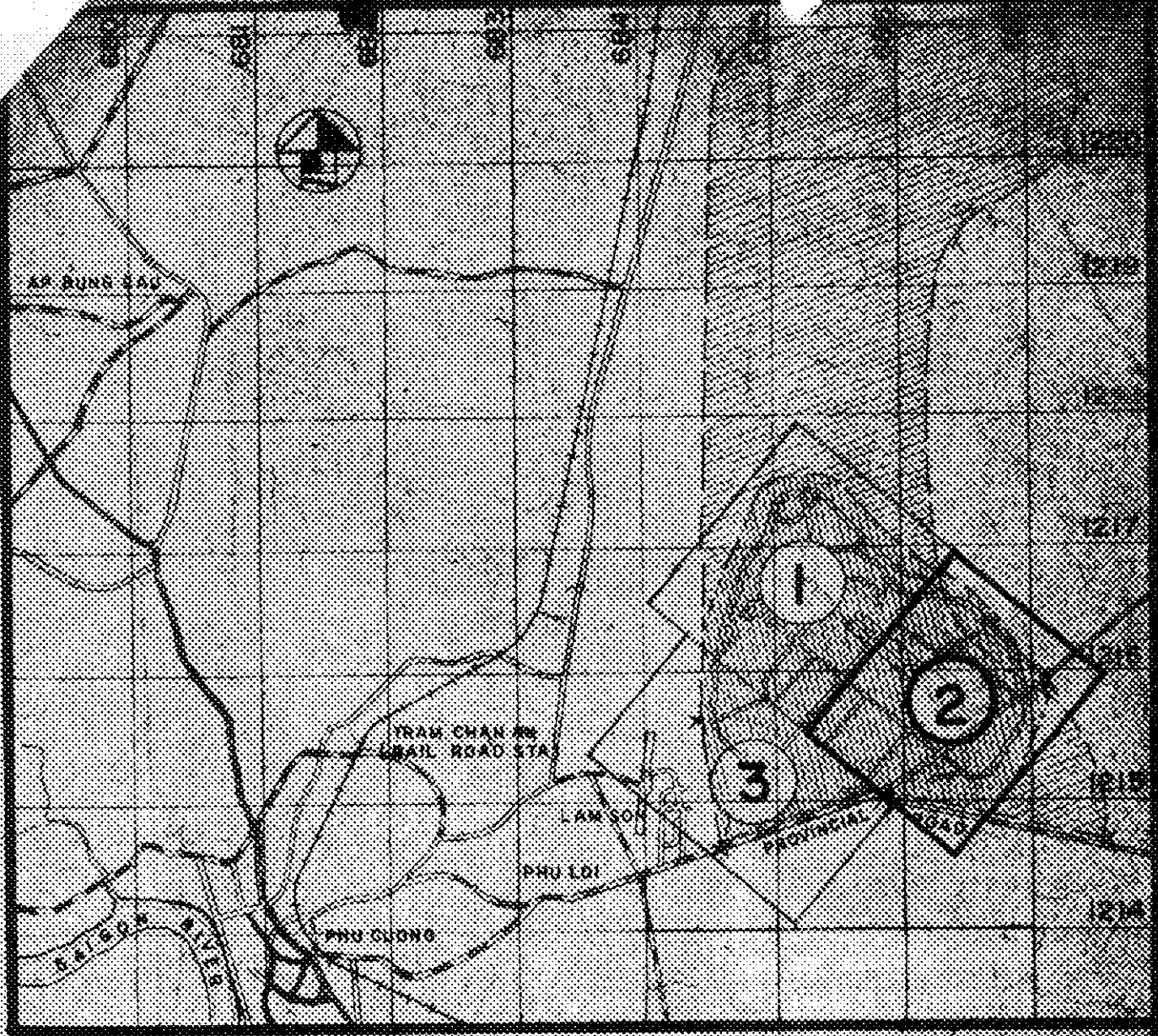
III
